

Proceeding of the Monthly Review Meeting of Block Development Officers of Shimla District under the Chairmanship of worthy Deputy Commissioner, Shimla on 16.06.2016 at D.C. Office Shimla.

In the monthly review meeting of the BDOs the following decisions were taken:-

❖ **Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA)**
MGNREGA

- All the BDOs were directed to review the GP wise status of the payment of delayed compensation 2015-16 and 2016-17 and it was directed by worthy Chairman to take action before 30th June 2016.
- All the BDOs were directed to ensure 100% aadhar Seeding of MGNREGA active workers into nregasoft and also the 100% conversion into Aadhar Based Payment by 30th of June, 2016. Block Development Officers were directed to involve LDM & bankers in conversion process .
- All the BDOs were directed to gear up the progress of work completion for the FY 2015-16 and FY 2016-17 on MIS by 30th of June, 2016 positively.
- All the BDOs were directed to issue more muster rolls and also to filled up the same well in time so that the monthly target for mandays generation can be achieved. In particular BDO Chhohara was directed to gear up the progress as the progress of mandays generation of Dev. Block Chhohara was zero.

❖ **Indira Awas Yojana (IAY)**

- All the BDOs were directed to ensure 100% MIS entry of release of 1st installment to beneficiaries sanctioned for the FY 2015-16. And it was directed to report all the issues related to IAY MIS through email to DRDA within 2 days.
- ❖ Directions were given to BDOs to ensure completion of all the houses sanctioned under the schemes in year 2015-16 before the formal launch of PMAY in August, 2016. The State govt. has assured to release the 2nd installment before the launch of PMAY. Besides directions were given to ensure its uploading on Awas-soft well in time so that funds of PMAY could be received uninterruptedly and benefit extended to needy people in the District.

❖ **Rajiv Awas Yojana (RAY)**

- BDOs to ensure to release 2nd & 3rd installments to beneficiary and 100% MIS by 30th June, 2015.

❖ **National Rural Livelihood Mission (NRLM)**


- All BDOs (Except Jubbal) to gear up the progress of SHGs formation.
- All BDOs must ensure sponsoring more cases for Credit Mobilization to Banks & Proper Follow-up.
- BDO Narkanda, Mashobra & Rohru must ensure to Submit the List of Non NRLM Compliant SGHs (Soft Copy and Physical Copy) within 2 days.

- BDO Basantpur, Theog, Rampur, Chopal & Chhohara to ensure utilization of funds (all components) immediately.
- All BDOs to ensure upload the NRLM SHG Data on MIS Portal formed after 01-04-2013 by 30th June, 2016.
- All BDOs must ensure to send the list of candidates who have complete 100 days work in MGNREGA (FY 2014-15) for trained under Life-MGNREGA within 2 days.
- All BDOs must ensure to send the report regarding Availability of land for Multipurpose Training –cum-Marketing Centers (150Sqm. Area).
- ❖ **Mukhya Mantry Awas Gram Yojana (MMAGY)**
 - The BDOs Mashobra, Jubbal, Basantpur & Rohru to ensure the submission of estimates under MMAGY with in a week's time.
 - All BDOs to ensure to submit the monthly progress report (Physical & Financial) for the month of May, 2016 within two days.
- ❖ **SBM (Gramin)**
 - The Chairman directed BDOs to enhance the progress of c/o individual household toilets and in the mean time upload the same on MIS.
 - The BDOs were also directed to submit the action plan of 150 GPs to be selected for placement of S&LWM during 2016-17 so that as soon as funds are received from GOI so that the same could be provided to selected GPs after obtaining approval of DSBM.
 - The BDOs were directed to ensure formation of clusters and providing detail to DRDA alongwith contact detail of cluster head, so that they could also be contacted for enhancing the progress of different components of SBM to declare district ODF by December 2016.
 - The BDOs appraised the chair that in the absence of Tablets they are facing problems in uploading photographs on MIS. The Blocks in which these Tablets are lying were directed to provide 3 Tablets each to Blocks where Tablets are not provided by RDD to speed up uploading of photographs on MIS for one month. (letter will be issued separately).
 - The reports of Blocks reveal that huge unspent balances are lying with blocks and this is adversely affecting the smooth flow of funds from State Government. Chairman directed BDOs to ensure the utilization of balance funds at the earliest manner so that smooth flow of funds to achieve remaining targets could be received and district could attain ODF status by December 2016.
 - The BDO Chopal suggested that permission may be granted to him to divert funds from other components in which it is lying unspent for releasing incentive to IHHLs who have constructed toilets. The chairman directed that proposal may be submitted to DRDA by BDOs, so that further action in the matter could be taken according to the guidelines of the SBM (G).

❖ Below Poverty Line (BPL).

- Only the BDO Mashobra & Nankahri have initiated installing BPL plate indicating details, rest of the BDOs to initiate action at the earliest
- The Chairman reiterated that all BDOs must make efforts to elevate the position of district by ensuring timely MIS entries in all major flagship programmes & also their updation.

The meeting ended with a vote of thanks to the chair.
