Sir/Madam,

this regard:-

With reference to this office letter no DRDA(S) MGNREGAMIS-2015-16-1492-99 dated 23rd March 2016 vide which you were directed to ensure 100% aadhar seeding of active MGNREGA workers by 31st March, 2016. But it is a matter of great concern that the performance of some blocks is still not up to the mark. As you might be aware that a Bill (No.18) regarding the Aadhar has also come into place. The Bill intends to provide for targeted delivery of Financial and Other Subsidies, Benefits and Services to individuals residing in India by assigning them Aadhaar numbers.

To achieve the target of 100% aadhar seeding of all registered workers, you are hereby directed to start a special campaign from 15th May to 15th June, 2016 in your respective blocks.

The following actionable points are to be undertaken in

- Downloading the list of workers without aadhar from MGNREGA website and the list of workers with aadhar on MIS, which are not linked with the
- banks, and circulate the same to the concerned GRS by 20th May, 2016.
 Downloading the list of those workers from PO login who are already enrolled with aadhar, but not linked with the banks. The list may be handed over to the concerned bank branch to get seeded in beneficiaries account.
- Wide publicity to cover left out workers through print & electronic media to be ensured on priority.
- Priority to cover those who are appearing without aadhar in active current year only and those who are appearing without aadhar in the report of active MGNREGA workers followed by other registered workers.
- To cover the left out workers, door to door visit of GRS may be ensured by all the BDOs. The benefits of seeding bank accounts with aadhar numbers may be explained to all grassroots level functionaries, SHGs & MGNREGA workers.

Wide publicity of Aadhar based payments and Job card updation be ensured 6. during the training/camps/GP meetings and Gram Sabha, if conducted during the course of this campaign.

To cover the left out MGNREGA workers without aadhar, BDOs should tie up 7. with the Aadhaar enrollment Centres and move them to those places where aadhar enrollment is poor. Three special enrollment kits (apart from permanent enrollment centres) for Dev. Block Rampur, Chhohara and Chopal have already been deployed to cover the left out workers. (BDO Rampur, Chhohara and Chopal may ensure to cover all left out workers on

on MIS be ensured on priority.

BDO should monitor GRS/GP wise progress on a daily basis as the same 9. would be reviewed by the undersigned almost district level.

However if any issues regarding the uploading of aadhar on MIS or other errors on MIS are noticed, they may be conveyed through telephone or email immediately to DRDA.

This must be given top priority.
